THE CENTER NOT ONLY PROVIDES A PLACE TO LIVE, BUT ALSO ASSISTS THEM WITH FREE IN-HOUSE EDUCATIONAL PROGRAMS, LEGAL ADVICE AND HEALTH CARE WHILE LIVING IN A LOVING AND CARING ENVIRONMENT.
